本通知書須於裝櫃或拆櫃開始前二十四小時向香港海關呈交。如工序的詳情有任何變更，已更新資料的通知書須於該工序前四小時另行呈交。如該變更涉及工序延遲進行，四小時前通知的規定須由上一次呈交的通知書所提供的工序時間起計。不遵守此項指示，將會被視作違反《應課稅品條例》。

This notification shall be sent to the Customs and Excise Department 24 hours before the vanning or devanning operation begins. If there is any change in the particulars of the operation, a revised notification shall be sent 4 hours before the change takes effect. If the change involves a delay in the operation, the requirement of 4-hour prior notification shall be counted from the time of operation as provided in the last submitted notification. Non-compliance of the aforesaid direction will be a breach of the Dutiable Commodities Ordinance.
