- (6) unlicensed money service (exchange of foreign currencies, remittance, etc.);
- (7) selling a motor vehicle subject to the First Registration Tax in Hong Kong at a price higher than the approved published retail price;
- (8) smuggling activities, illegal manufacturing, possession of or trafficking in the following articles:
 - strategic commodities
 - obscene and indecent articles
 - dangerous drugs (heroin, ketamine, cocaine, cannabis, etc.)
