The original of this authorization shall be the only valid copy against which the chemical stated overleaf may be released by the responsible person of the carrier to the importer on arrival in Hong Kong unless special authority to permit release against a certified true copy is granted in writing by the Commissioner of Customs and Excise or an officer authorized by him.
2. 本授權書正本下開空格內必須填寫貨物的抵達詳情，然後交給船公司或航空公司或貨物處理公司，再由該公司將詳情與有關提單或航空提單或提貨單及倉單核對。
The arrival details of the shipment must be shown on the original of this authorization in the space provided below before the authorization is presented to the shipping company or airline or cargo handling company who should check details against the relevant Bill of Lading or Air Waybill or document of taking delivery and manifest.

the intended place of storage of the chemical; and
 - (c) 該化學品的購買人或最終使用人的姓名及地址。
the name and address of the purchaser or end-user of the chemical.
