- (2) *No person shall keep or store any substance specified in Schedule 1 or 2 of the Ordinance except in a container approved in writing by the Commissioner*
- (3) *The container in which any substance specified in Schedule 1 or 2 of the Ordinance is kept or stored -*
  - (a) *shall be clearly marked on the outside thereof with the English and Chinese names of the substance as specified in the appropriate Schedule; and*
  - (b) *shall not contain any substance other than the substance so marked thereon.*

## **Personal Information Collection Statement**

### **Purpose of Collection**

1. The personal data provided in this form as well as any updates of them will be used by the Customs and Excise Department (the Department) for one or more of the following purposes:
  - (a) discharging various duties and functions of the Customs & Excise Department;
  - (b) enforcing the powers conferred upon the members of the Department by laws; and/or
  - (c) facilitating communications among staff members of the Department, other Government departments/bureaux and yourself for processing of the application.
2. Matching procedure within the meaning of the Personal Data (Privacy) Ordinance (the Ordinance) may be employed to facilitate the processing of the data for the above mentioned purposes. Matching procedure means the comparison of personal data provided by the applicant with the existing records (e.g. conviction record) kept by the department, other departments/organizations to ensure that the applicant is satisfied with the requirements of the application.
3. It is obligatory for you to supply the personal data as required by this form. If you do not provide sufficient information, we may not be able to process your application.

### **Classes of Transferees**

4. The personal data your provided in this form as well as any updates of them may be disclosed to other Government departments/bureaux or organizations for the purposes mentioned in paragraph 1 above; or where such disclosure is authorized or required by law.

### **Access to Personal Data**

5. You have a right of access and correction with respect to your personal data as provided for in the Ordinance. Your right of access includes the right to obtain a copy of your personal data provided in this form. In accordance with the terms of the Ordinance, we have the right to charge a reasonable fee for the processing of any data access request.
