2. Distribution of copies:
 Original—To be retained by the Permit Office.
 Duplicate & Triplicate—To accompany the goods. After endorsement of Part III & IV, the duplicate will be returned to the Statistical and Research Division at **30/F, Customs Headquarters Building**, by the bond officer or the authorized person, the triplicate will be retained by the permit holder.
3. For goods attracting ad valorem duties, values of goods must be declared in a Declaration Form CED 129 which must be supported by submission of invoice, bill of lading or air waybill and other documents relating to the goods.
4. Normally 2 working days are required for processing an application.

“Warning: It is a criminal offence to contravene the conditions of issue and to furnish any incorrect information. Maximum penalty will be a fine at level 6 plus imprisonment for 1 year and \$1,000,000 plus imprisonment for 2 years respectively.”

PART II: APPROVAL

CONDITIONS OF ISSUE

- (1) If the permit cannot be used the permittee shall return it to the issuing office within 7 working days from the last removal date stated overleaf.
 - (2) If the goods are not removed to the place on the date specified on this permit, the permittee is required to return the shut-out cargo to:
during office hours
#a warehouse as defined in section 2 of the Dutiable Commodities Ordinance, Cap. 109;
after office hours
the Customs and Excise Warehouse or a #warehouse in the case of containerised cargo (Tel No. 3759 2288).
 - (3) The permittee shall be liable for the payment of duty in respect of any discrepancy of goods described overleaf.
- # Warehouse means a public bonded warehouse or a licensed warehouse or a general bonded warehouse.

Permission is hereby given for the removal of the goods in accordance with the date, time and manner, and from and to the places specified overleaf and subject to the conditions as shown above and chopped overleaf.
