

深化大灣區AEO合作 - 積極協助香港AEO獲取內地AEO認證

Enhance AEO Cooperation in GBA – facilitate HKAEOs in obtaining Mainland AEO Certification

Hong Kong Customs continues to contribute to enhancing AEO Cooperation in the Greater Bay Area.



► 香港AEO「利記國際有限公司」的內地公司「深圳市利昌中興貿易有限公司」於今年一月成功獲取內地AEO認證。
"LKG Elite (Shenzhen) Co., Ltd.", a Mainland company of HKAEO "Lee Kee International Limited", was accredited as a Mainland AEO in this January.

為積極落實《深化粵港澳大灣區AEO合作的備忘錄》，在去年12月，香港海關人員率領由五間香港AEO組成的代表團前往「中國海關AEO實訓基地（深圳）」進行考察，並與內地海關AEO團隊進行直接交流。同時，香港海關積極與內地海關協調和跟進香港AEO申請內地AEO認證的事宜，協調雙方處理申請時遇到的問題，協助加快認證的時間。今年1月，代表團成員之一「利記國際有限公司」的內地公司「深圳市利昌中興貿易有限公司」成功獲得內地海關的AEO認證，見證兩地深化AEO合作的新里程。

香港海關會繼續與內地海關保持緊密合作，發揮「AEO超級聯繫人」的角色與功能，持續為深化大灣區AEO合作事宜作出貢獻。

To implement the "Memorandum of Understanding on Enhancing AEO Co-operation in the Guangdong-Hong Kong-Macao Greater Bay Area", Hong Kong Customs officers led a delegation of five Hong Kong AEOs to the "China Customs AEO Training Base (Shenzhen)" last December for direct communication with AEO officials from the Mainland Customs. In addition, Hong Kong Customs actively coordinates with the Mainland Customs to follow up on Hong Kong AEOs' applications for the Mainland AEO certification, help overcome potential hurdles and expedite the accreditation process. In January this year, "LKG Elite (Shenzhen) Co., Ltd.", the Mainland company of one of the delegation members, "Lee Kee International Limited", successfully obtained AEO accreditation from the Mainland Customs, marking a key milestone in AEO cooperation between the two sides.

Hong Kong Customs will continue to collaborate closely with the Mainland Customs and act as an "AEO super-connector", further enhancing AEO Cooperation in the Greater Bay Area.
