海關助理關長(稅務及策略支援)吳鎮華率領一眾海關人員於本年11月17至18日出席由香港特區政府與貿易發展局合辦、於香港會議展覽中心舉行的第15屆「亞洲物流航運及空運會議」，會場匯聚物流、航運、空運、供應鏈業界等精英，海關人員藉此活動擺設展覽及進行研討會，向在場人士重點介紹多項海關便利商貿計劃，包括：「香港認可經濟營運商計劃」、「自由貿易協定中轉貨物便利計劃」、「跨境一鎖計劃」、「跨境快件清關便利安排」、「空陸鮮活產品專屬快線」、「貿易單一窗口」，以及「內地與香港貨物『一單兩報』」，協助物流業界節省成本及提升競爭力。

香港海關一直致力推出各項便利商貿措施，為企業提供多項通關便利，幫助企業拓展區域以至全球發展商機。

The Conference gathered professionals from logistics, maritime, aviation, and supply chain industries. Hong Kong Customs seized the opportunity to set up an exhibition booth and conduct a seminar during the event, showcasing various trade facilitation measures, including the "Hong Kong Authorized Economic Operator (AEO) Programme", "Free Trade Agreement Transshipment Facilitation Scheme", "Single E-lock Scheme", "Cross-boundary Express Cargo Clearance Facilitation Arrangement", "Air-Land Fresh Lane", "Trade Single Window" and "Mainland-Hong Kong 'Single Submission for Dual Declaration' Scheme on Cargo", thereby assisting the logistics industry in reducing costs and enhancing competitiveness.

Hong Kong Customs has been actively implementing various trade facilitation measures to enhance Hong Kong's business environment with an aim to providing multiple trade facilitation benefits for enterprises, for further exploring regional and global business opportunities.
