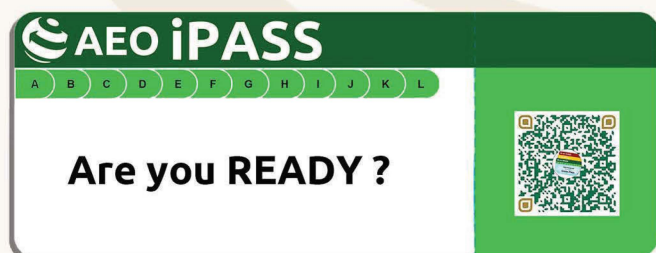
我們明白有些公司未必完全掌握各項認證標準要求, 或是對公司的供應鏈安全水平是否達到計劃要求有所疑慮。有見及此, 我們推出了AEO iPASS 網上自我評估工具, 讓有意成為AEO的公司可更簡易及快捷地了解公司的供應鏈安全水平及是否具備申請成為AEO的條件。

Online Self-Assessment Tool

Want to be a Hong Kong Authorized Economic Operator (AEO)? Local companies engaging in supply chain activities which have met predetermined security standards can apply for AEO status and thereby enjoying various benefits.

Some companies may not fully grasp the accreditation criteria or have concerns on whether their security levels can match up with the required standards. In this regard, We have launched the AEO iPASS – an online self-assessment tool which enables companies to know their supply chain security level and the readiness to be an AEO by conducting simple and quick self-assessment.

協助中小企提升供應鏈安全水平

附設於香港海關網頁的AEO iPASS列出了相關認證標準和評審所需文件, 公司只要花大約15-20分鐘回答簡單的評估題目, 便可獲得該公司的供應鏈安全水平及是否具備成為AEO的條件的一個初步評估等級和參考分數。評估結果同時會顯示海關提供的改善建議, 並附上相關網上培訓教材的連結。我們期望本地公司, 特別是資源相對緊絀的中小企, 可以透過AEO iPASS引入供應鏈安全的最佳作業方式, 從而提升內部管理水平, 並為正式申請成為AEO作好準備, 邁向無限商機。

Enhance Supply Chain Security Levels for SMEs

Accessible via the C&ED website, the AEO iPASS enlists the required documents and standards upon the accreditation criteria in detail. By spending 15-20 minutes to complete simple assessment questions, companies will receive a general grading and a score according to their supply chain security level and the readiness to be an AEO. The result will come with Customs advices for improvement and hyperlinks to related online training materials. We envisage that local traders, particularly Small and Medium Enterprises (SMEs) with relatively limited resources, will be able to use AEO iPASS to enhance their management level by sharing the best practices in supply chain security while getting ready to apply for the AEO status.
